

TROT (Toll Rides Off-Road Trust) Application for Membership **RULES AND CONDITIONS OF RIDING LICENCE**

I hereby apply for a licence to ride a horse/pony on Private Land Toll Routes and/or in some of the Forests managed by the Forestry Commission (FC) and designated by FC as suitable for riding and where Toll administration is managed by TROT. I accept and agree that this licence will be personal to me (or the child for whom I am applying) and will not be transferable, and undertake not to give or lend the TOLL RIDE (OFF-ROAD) TRUST (TROT) hat band to any other person. I will return the hat band immediately if I wish to discontinue my riding licence. I will remain liable for THE LICENCE FEE on any hat band held in my possession until the hatband is returned to TROT. The child or I will comply with the Riding Regulations as set out below.

I am aware and accept that: Toll Routes are not owned by TROT; Toll Routes and Forest riding facilities will only be open during daylight hours; FC and landowners of Toll Routes reserve the right to close or restrict horse-riding routes for the purposes of Forestry, farm or land management, or other purposes; Toll Routes and Forestry riding facilities may be closed during wet weather and all toll routes will be closed on Christmas Day.

I agree that neither TROT nor FC (nor any landowner or farmer over whose land there is a Toll Route) is responsible for the safety or condition of any Toll Route or Forest Route or place in any Forest where riding can take place and that the child or I will ride entirely at our own risk and will rely only on my inspection of the terrain. I will indemnify TROT and FC and any landowner against any claim made by myself or by or on behalf of the child in respect of any injury loss or damage suffered by the child or myself while riding on any Toll Route or in any of the Forests or by any person arising out of my or the child's riding. I understand that any licence to ride issued pursuant to this application will not be valid or effective if either the relevant licence fee has not been paid up to the date when it became due or if the rider is not wearing the appropriate hatband or other means of identification currently in force.

I have and will maintain adequate third party and liability insurance to cover any claims arising out of riding by myself or the child on any Toll route or in any of the forests.

I agree that by riding on a Toll Route or in a Forest the child or I will not claim any legal Right of Way over the land on which we will be riding and will only ride as licence holders of FC or the landowner. I understand that this agreement is without prejudice to any evidence for a public right of way in any current or future existence.

The child and/or I will accept the decision of TROT if any complaint is made about our use of any Toll Route or of the riding facilities in any of the Forests. I accept that TROT, FC and the landowner are entitled to withdraw the licence and hatband at any time upon giving me notice thereof in writing. On return within 2 weeks of the expiry of the hatband and keys, if applicable, TROT shall return to me the deposits for which I shall have paid.

RIDING REGULATIONS

1. I agree not to abuse any Toll Route or any of the Forests.
2. I agree to wear the coloured and numbered hatband issued to the licence-holder at all times when riding on a Toll Route or in any of the Forests.
3. I agree to wear a properly fitted and British Standard Approved riding hat at all times, and to ensure that the horse/pony being ridden is appropriately tacked up for riding with sound tack.
4. I agree to stay strictly on the Toll Routes indicated on the maps issued to me and by the TROT waymarkers, and/or within the FC permitted riding areas in the Forests. Not to ride on crops or ride irresponsibly if the going is soft. To close any gates which the rider has to open. Not to disturb livestock or wildlife. Not to take any dogs on the Toll Routes. To keep any dogs taken into the Forests under control.
5. I agree to check the route maps and newsletters issued to licence-holders and the signs at the end of each route for the exact details.
6. I agree not to use cross-country jumps on Toll Routes unless accompanied by a responsible adult. Not to erect or use any jump in any Forest, unless with prior permission from the Forestry Commission.
7. I agree while riding in the Forests:
 - a. To observe FC bylaws.
 - b. To enter and leave all Forests only at authorised points and close/lock all gates after passage.
 - c. To show courtesy and consideration to all other users of the Forests.
 - d. To comply with any direction given by a Forestry Commission Officer or his authorised representative.
 - e. To avoid any area in which there are FC felling operations.

f: Not ride in any part of the Forests in which "No Riding" signs have been erected.

Provisional Rates – some particularly short routes may qualify. Your horse/pony may need to be stabled in the Parish where the route is situated or some other local condition will apply. As at July 2006 this rate only applies to ES01 Heathfield, E Sussex, WS05 Ashurstwood, W. Sussex. Any queries please contact your Local Agent or Admin Office.

1. **Disabled Riders Are Free - No Membership or Toll Fees, Just Hatband/Key Deposits** - Please fill in application form and send with deposits enclosing some evidence of your disability.
2. **Refunds** - fees outstanding will be given only in exceptional circumstances e.g. Injury to horse or rider (Vet's/Doctor's certificate will be required). Any refund will be calculated from the 28th of the month in which we receive notice in writing together with returned hatband and keys.
3. **Keys** - Please contact your Local Agent (number on Agent's Area and Telephone list or telephone office) to find out what types of padlock are in use on the routes which you wish to ride. Some areas have combination padlocks and you can obtain this from the Local Agent once you have joined. All keys require a £10 deposit. TROT Farm/Private Land routes have a different key to Forestry Commission land. Please indicate your requirements below and add any deposit to your cheque.
4. **Insurance** - Please give details of your Insurer. NB. Should an accident or incident arise from a person not registered as riding with TROT but using your hatband then TROT, the Forestry Commission or the Landowner, or their Insurance Company could pursue a claim against you personally. Please do not underestimate the implications of this condition. **Never lend someone else your Hatband.**
5. **Data Protection** - Please let us know in writing if you object to your name being kept on our database for membership purposes only.
6. **Shared/Family Horse or Pony** - Please give full names and addresses of all riders on the back of the form. It is your responsibility to ensure that they read and comply with our Rules and Conditions. Make sure your Third Party Liability covers you for other people riding your horse or pony.
7. **Renewals** - You will be sent a Renewal Request Form approx. 4 weeks before your membership expires. We will usually send out First Reminders 2 weeks after the expiry of your membership. Renewals sent late will be strictly backdated to the date due.
8. **Please Note Very Carefully Indeed** - If you wish to end your membership you will remain Liable for any fees accruing on your membership unless you return your hatband and keys to the Admin Office within 2 weeks of Expiry of Membership. This is a Legal Requirement on us, the Trust. Farmers/Landowners can demand payment for all hatbands we are unable to account for, i.e. not returned to us.
9. **Furthermore - Late Renewals** will be subject to an Admin Penalty fee (£5 per reminder) so please renew on time. Thank You!
10. **Important information**
 - Your hatband has your individual licence number printed on. This is your licence to ride on Toll Rides - Farm or Forestry.
 - Only those named as shared riders on your record (on our database) may use your hatband.
 - You are required to pay an annual licence fee for which we will send you a reminder one month prior to your renewal date.
 - We ask that you return your cheque with the renewal form promptly if you wish to continue to enjoy the Toll Rides.
 - If you wish to put your membership on hold or retire from the Toll Ride scheme, you must return your hatband and any keys to TROT HQ.
 - You are liable for any outstanding fees until we receive your hatband and keys.
 - Toll Ride hatbands remain the property of TROT at all times.
